### Valid proof of identity

The Norwegian Public Roads Administration (NPRA) accepts a copy of any of the following documents as proof of identity:

- Norwegian passport (not emergency passport)
- Norwegian bank ID card with photo
- Norwegian driving licence issued after 1 January 1998
- ID card issued by the Norwegian Armed Forces
- Norwegian Sea Service Book
- Norwegian Postal Service ID card
- Norwegian travel document for refugees
- Immigrant's passport (not accepted if issued for a single journey)
- Foreign passport (not emergency passports)
- ID card from EU/EEA countries

All Norwegian ID documents must have both a photograph and a national identity number/D number (11 digits). Your proof of identity will not be accepted if your national identity number/D number is illegible or only partly visible.

### List of personal data that may be registered within the different categories

**Driving licences:** Driving licences and other certificates of competence related to driving vehicles (such as Driver CPC/Driver Qualification Card, ADR Driver Training Certificate, CPC for drivers of emergency vehicles).

**Vehicles:** Information related to vehicles you own or have owned.

**Supervision and inspections:** Information related to inspections of vehicles, road users, workshops and driving schools.

**Roads:** Information related to the planning, building, operation, maintenance and management of roads, bridges and tunnels (such as documentation regarding the expropriation of property, consultative statements, zoning plans).

**Transport:** Information related to tasks in connection with traffic management and control and other societal functions (such as documentation related to work notifications, enquiries from the public, accident analyses, studies and reports, strategies, action plans for a superior authority, and R&D projects).
